No telephone entries will be accepted.  
\*\*Each contestant will receive a complimentary pass which you will need to pick up from the fair office. Parents, Guardians, or anyone accompanying the contestants must purchase their own ticket.

2. **CONTEST RULES**

Vocal acts are to be no longer than 4 minutes. Variety acts are to be no longer than 3 minutes. **NO EXCEPTIONS!**  
All contestants must be at the Sales Facility at the fairgrounds by 2:00 p.m. to turn in music.  
No cassettes tapes will be allowed - CDs only. They must be clearly marked with contestant's name and the song title must be written on the case.  
Sound System will be provided

ALL ENTRIES WILL BE JUDGED THE DAY OF THE TALENT SHOW ON THE BASIS OF TALENT, SHOWMANSHIP, AND STAGE PRESENCE.

**DECISIONS OF THE JUDGES ARE FINAL.**

CONTESTANTS ARE RESPONSIBLE FOR PICKING UP CDS AFTER THE SHOW. THE FAIR ASSOCIATION IS NOT RESPONSIBLE FOR ANY CDS LEFT AFTER THE SHOW.
